1. It is agreed and understood by applicants that receipt of this document becomes a contract between an applicant and the K of C Villa Marie Council # 6342 Italian Festival.
2. Alcoholic beverages shall not be sold or distributed as per State Law by the vendors. Vendors who disregard the law, shall be closed and not receive a refund. Rights reserved by K of C Villa Marie Council # 6342 Italian Festival to refuse space which it deems detraction from the dignity of the festival. All Vendors must be in compliance with State and Local Laws.
3. All vendors will provide their own: **Food Carts, tents, tables and chairs.**
4. Displays are to be arranged so as not to hide adjoining vendors.
5. Vendors shall assume responsibility for the safety of their merchandise and displays, against loss or damage by: Fire, theft, accident or any destructive cause while on the Smithville Greene property.
6. Vendors will accept locations as assigned and shall only use display racks for self-supporting boards or structures that fit in their assigned area.
7. Storage of all extra merchandise, cartons and containers shall be out of sight. We are expecting all of our vendors to present their wares in a professional manner with your name clearly displayed.
8. Vendors SHALL BE SETUP prior to 9:30 AM, on the day of the festival. You shall not break down prior to close of the event at 5:00 PM. Vendors arriving after 10:00 AM shall not be allowed and fees will not be returned.
9. Vendors are responsible for the removal of all their trash.
10. Each vendor shall provide a representative to be on hand for the sale of their merchandise and hereby release the Knights of Columbus, Villa Marie Council # 6342 from any and all responsibility for the loss or damage of vendor materials. Vendor agrees to be responsible for all monies handled at their location.
11. You shall fill out the attached Health Department Application and mail to the address on top of the application.
12. You shall provide enough serving personnel to keep waiting lines to a minimum.
